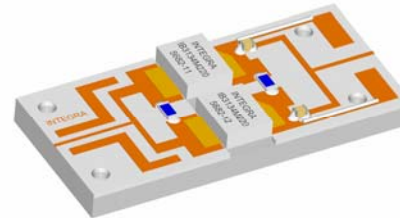


S-Band Radar Pallet

Part number IBP3134M220 is a 50 Ω matched high power pulsed radar pallet amplifier for S-Band radar systems operating over the instantaneous bandwidth of 3.1-3.4 GHz. The pallet amplifier supplies a minimum of 220 watts of peak pulse power under the conditions of 100μs pulse width and 10% duty cycle. All units are 100% screened for large signal RF parameters.

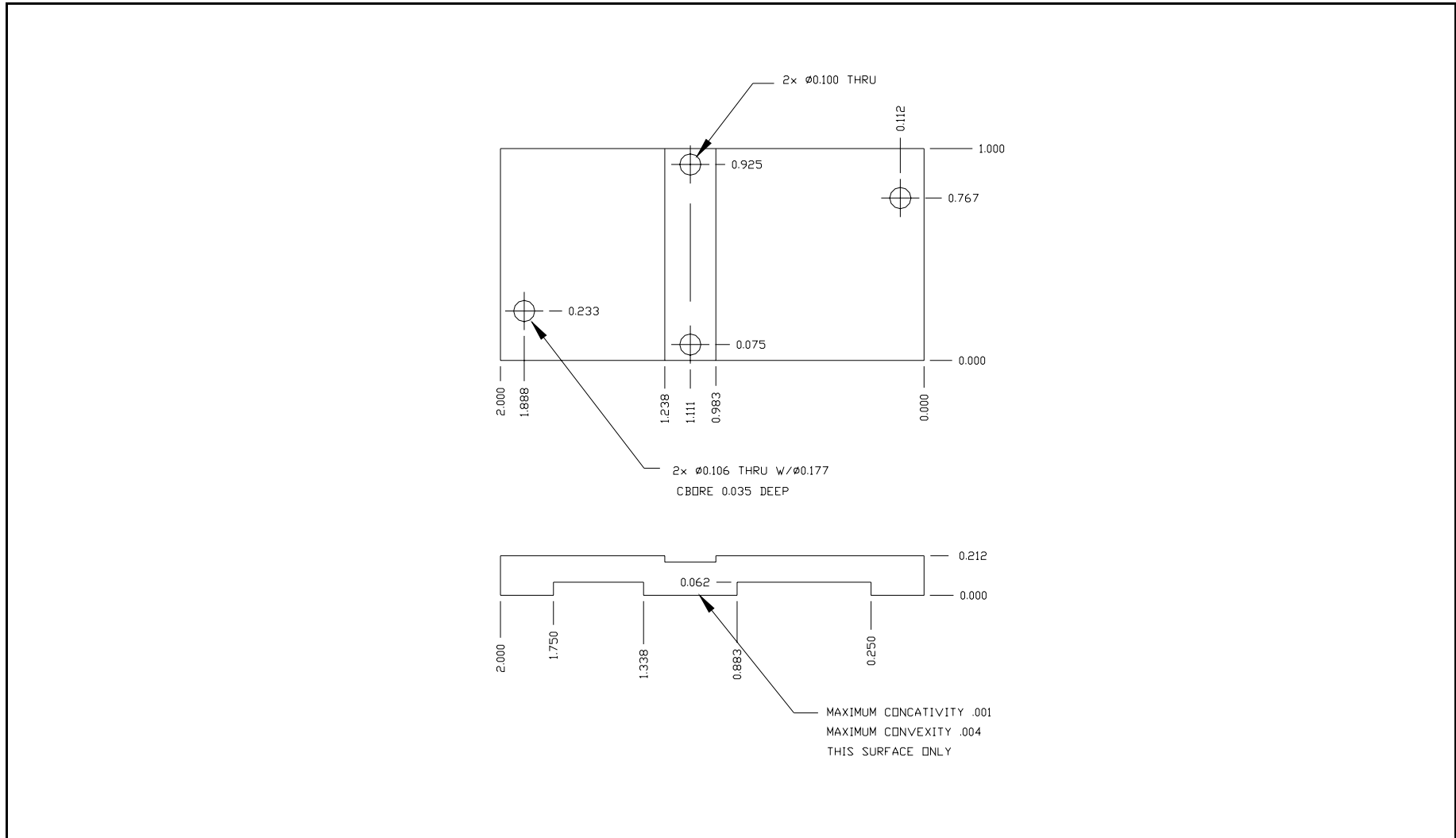
